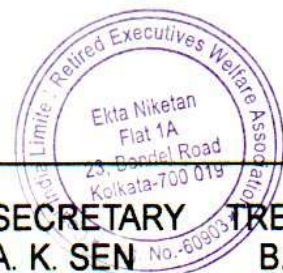

Sub: Treatment of the Retired Executives affected by
COVID-19 at the empanelled Hospitals of CIL.

Dear Sir,

Your kind attention is drawn towards the fact that there is a huge crisis of treatment of Covid-19 patients in Private Hospitals in all places especially at Kolkata at the moment due to shortage of Bed. The situation is alarming in case of the Retired Executives of CIL since all the Private Hospitals are refusing admission presumably in the CGHS rates (though they are not officially coming out with the mentioned reason openly). We were trying for the admission of one of our retired colleague, affected by Covid-19 since last few days and was in need of immediate hospitalization due to reduced oxygen saturation, in almost all the empanelled hospitals for three days but in vain. The issue of refusal of admission / treatment by Private Hospitals in CGHS rates was also discussed with your good offices. At this hour of Covid pandemic it has become a question of life and death for the Retired Executives since they are most vulnerable if affected by Covid-19, due to the age factor and co-morbidity factor, which is very common at this age.

It is our earnest request to your good offices to kindly come out with a solution which may be a lifesaving one for the Retired Executives of CIL by holding an urgent meeting with the Hospital Administration of all the empanelled hospitals especially in Kolkata and come out with a negotiated rate particularly for Covid-19 treatment considering the same as a special issue and approve the same to ensure seamless treatment for the Retired Executives.
