Dear Sir,

It was an immense pleasure in meeting you on 17.03.2020 to convey our heart filled congratulations on behalf of the Coal India Limited Retired Coal Executives Welfare Association (CILREWA) for assuming the charge of Chairman-Cum-Managing Director, the highest coveted post of Coal India Limited. We also thank you and Director (P&IR), CIL for giving a patient hearing to some issues related to the retired executives of Coal India Limited.

Issues discussed were as under:

1. Payment of interest on NPS for delayed settlement of annuity payment from corpus of CIL Executives Defined Contribution Scheme- 2007:

Matter relating to huge loss suffered by the retired executives of CIL due to delay in implementation of the Annuity Scheme for various reasons like (a) delay in formation of Trust / Fund; (b) delay in start of payment of Annuity; (c) substantial drop in rate of Annuity during last ten years and the like were explained to you in brief.

You were kind enough to consider the issue in a positive note and also agreed to take up the issue with MOC, Govt. of India.

2. Consideration for Super Senior Citizens:

A proposal was submitted earlier with the request to grant for special ex-gratia to the senior citizens who have attained the age of 75 years and above. Matter was explained by Sri N. C. Jha, Former Chairman, CIL.

It was told by the CIL Management that this issue can be considered on merit subject to availability of fund based on actuarial valuation and also is not against any Govt. principles and directives.

3. Settlement of CMPF pension of spouse:

The difficulties faced by the spouse, specifically who are aged and settled at a distance place from their last posting (Place of retirement), to get the papers ready for initiation of Family Pension were deliberated.

This was agreed by CIL Management to take up the issue with the CMPF Commissioner for quick settlement of spouse pension.

4. Problems faced by retired executives related to Contributory Post Retirement Medicare Scheme (CPRMSE):

Great deal of difficulties in getting medical treatment, both OPD and In patient at the empanelled hospitals, from renowned and super specialist Doctors because of low consultancy charges (as per CGHS rates, approved by CIL) and denial of admission for non-availability of beds were also discussed.

CIL Management also agreed to look into the matter for redressal.

We earnestly request you to kindly pass on appropriate direction down the line for early resolution of the issues discussed in the meeting held on 17.03.2020.

Delay in sending the communication because of lockdown and / or disturbance for COVID-19 is regretted.
