

CILREWA NEWS BULLETIN No.1/2025 dated 30th June, 2025

A. CPRMSE ISSUES:

1. In cases where the medical bills, submitted during 2024-25, have not yet been paid because of change of the year from 2024-25 to 2025-26, claimants are requested to contact through e-mail id cilbpa@utiitsl.com and / or contact no 02267931116 for payment.
2. Letter bearing no CIL/C5A(PC)/ 1374 dated 20.06.2025 issued by the Policy Cell, CIL for 'Mandatory use of ERP/SAP module for claiming reimbursement and settlement of bills w.e.f. 01.07.2025' is applicable for on-roll employees only, as confirmed by PRB Cell, CIL. [Sri Jayanta Mukherjee, Retd. GM (F) on 23.06.2025 also mentioned about its non-applicability for retired employees].
3. CIL ERP Department has initiated a drive to inform updated position of individual retired employee's credit balance in CPRMSE Fund from time to time. A few test messages have already been sent by them, some of our members are recipients of such messages. It is gathered from CIL sources that the system is not yet stabilized, therefore, there are chances of errors in the figures reflected in the messages. This has been confirmed by the PRB Cell that they were not aware of sending any message by ERP Section regarding credit balance confirmation. (The lack of co-ordination between ERP & PRB Cell is thus very much apparent) It is, therefore, advisable that wherever members apprehend discrepancy between the figures mentioned and the actual position, they may bring this to the notice of the PRB Cell, CIL designated Cell for handling CPRMSE issues, in writing.
4. The issue of a few specialist doctors refusing consultation to CPRMSE Members in some of the listed hospital across the Country in CGHS rates was also taken up with CIL. While members may visit those doctors in their personal capacities and get reimbursement to the extent of Rs.1200/- , they may avail the diagnostic services from external listed hospitals and clinics, in case the consulting hospitals refuse to extent these services in the CGHS rates.

B. Status of issuance of Revised PPOs

1. As per the information collected as on 23.06.2025, company-wise status of issuance of revised PPOs (est.) is given below:

2. Letter no CMPFO-16022/4/2024-FIN-ACC Comp 3369/ 14 dated 22.04.2025 issued by CMPFO on CMPF Pension-SOP along with Annexure may please be referred again. Recently we, the representatives of CILREWA have observed that procedure for claiming spouse pension through SBI branches are working smoothly where revised PPO is available. But we are yet to experience anything about the procedure being followed by branches of other banks.

3. Delay for issuance of revised PPOs and the problem of non-receipt of revised PPOs from CMPFO by the pensioners were also discussed with CIL. It is gathered that these issues had already been taken up by CIL in the last Board of Trustees (BOT) meeting of CMPF. However, CILREWA requested CIL Management to tighten the leash for early settlements of the issues. However, members, who have applied but not yet received the revised PPO, may write to company HQ / Area offices handling delivery of PPOs/ Revised PPOs and maintaining records, quoting the reference of the application details, for forthwith delivery of a copy of the authenticated revised PPO. Copies of this letter should also be sent to concerned CMPFO and Director (Personnel) of the Subsidiaries.
