Subject: Issuance of revised PPO in respect of retired employees.

Sir,

On behalf of CILREWA, I intend to bring the following to your kind notice on the captioned subject.

The letter no CPF/CP/111(26)/PEN/MISC/HQ/VOL-III/520 dated 25/08/2023 of Commissioner, CMPF addressed to DP (CIL) and others, copy attached, has sought certain documents from CIL/Subsidiaries in respect of the retired employees for issuing revised PPO. In this context, our Retired Employees Association (CILREWA) has a few suggestions for expeditious completion of the job:

Though, in all cases, it can be safely presumed that information/documents are available with CMPFO as well as with Coal India and subsidiary companies, to expedite the completion of the job as demanded by CMPFO, the Association is of the view that a notice may be uploaded in CIL as well as subsidiary companies website to enable all retirees to upload the scanned documents viz: i) Name of the Pensioner (along with Father's Name) with Bank Details, ii) Existing Bank Account of the Pensioner with F or S mode, iii) Copy of Aadhaar and Pan card of Pensioner and Spouse, iv) Joint Photograph, v) Copy of present PPO/present PPO number(if not having copy of PPO), vi) Mobile Number of Pensioner and Spouse, vii) Email ID of Pensioner and Spouse, within a stipulated timeline. A suitable format if required, may be designed to cover all the details/information required for the sake of uniformity.

In light of the above, you are kindly requested to have a holistic view of the matter and decide in the best interest of retirees. This is a long pending issue and I am sure you are aware of situations where widows of deceased retirees face great hardship in the absence of proper PPO.

I, on behalf of CILREWA, earnestly hope that you and DP (CIL) will look upon the matter personally to resolve the issue.
