I, on behalf of CILREWA, would like to express our sincere thanks for meeting us and giving us a patient hearing on 29.07.2023, in spite of your busy schedule, for discussing the issues related to the retired executives of Coal India Limited & its subsidiaries regarding CPRMSE. CILREWA acknowledges the warm welcome extended to its members from your office.

CILREWA team was led by President Shri T. K. Nag accompanied by three other office bearers viz., S/Sri S. Chattopadhyay (Vice-President), A. K. Roy (Secretary) & U. Bhowmik.

The issues raised by CILREWA were discussed as under:

## **1. Consultation Charges for Doctors under CPRMSE**

The Management expressed their awareness of the situation regarding refusal for treatment at CGHS Rate by some Doctors of empanelled hospitals and assured that the problem will be looked into sympathetically after necessary examination and feedback from the Finance & Personnel Department of CIL.

## **2. Enhancement of Ceiling Limit of Rs 25 Lakhs for treatment of OPD & Hospitalisation expenses**

This issue, raised earlier on different occasions, is under active consideration and being looked into by the concerned department(s) of CIL.

### **3. Non-payment of interest to CPRMSE Trust Fund for delayed transfer of Fund [for the period from 01.01.2007 to 31.03.2018/29.06.2018]**

The Management emphasised that it would not be a problem to meet the legitimate demand of the retirees.

ED(Fin), CIL was told to discuss the issues mentioned, in depth considering all pros & cons with Sri U. Bhowmik of CILREWA before putting up a formal proposal for consideration.

### **4. Inclusion of provision in CPRMSE for reimbursement of medical expenses for treatment of Psychiatric Disorders**

It was told that this issue decided earlier, is already under consideration by CIL.

### **5. Consideration of Grant of Special Ex-gratia to the senior citizens who have attended the age of 75 years and above**

This proposal, if agreed upon, would be applicable to all those who attain 75 years or more every year. ED(Fin) CIL was asked to find out the number of such persons at present from the available records and to make a proper study of recurring financial impact on year to year basis.

We sincerely hope that the issues will be taken care of as discussed in the meeting and that appropriate direction will be given for early resolution of the issues.

On behalf of all the retired executives of CILREWA, I once again convey my sincere thanks for giving us the opportunity to share our thoughts with you in a very cordial and positive atmosphere.
