## **(3) Having association's office at own premises :**

(a) The proposal for purchasing own premises for the CILREWA office was discussed at length. With passage of time, the activities of the Association is expanding, the membership is growing, the volume of papers and official documents are increasing. \*\* Subject to approval by the General body in the AGM, we will take up various fund raising programs like charity shows, advertisement in souvenirs to be published on various occasions, sponsorships for our various programs including seminars, donations from our members, Unsecured loans but with clearly laid guidelines of making repayment of the same within the given time etc.,

## **6.2 Address by the Chief Advisor:**

Shri T. K. Nag, Chief Advisor recalled the various steps taken by CILREWA during the year 2023-24 for issuance of Revised PPOs and formulation of Standard Operating Procedure (SOP) for hassle free commencement of spouse pension. He stated about various meetings held with the Chairman, CIL for taking up the relevant issues with CMDs & Dir (P)s of subsidiary companies to impress upon the Regional Commissioners of CMPF for speedy settlement of the matters. He expressed satisfaction that SOP for settlement of spouse pension has been formulated and issued, pursuant to which CILREWA team is organising Awareness Programs, zone wise, to appraise the spouses regarding the latest developments and the procedures to be followed. He further stated that the issuance of Revised PPOs is also getting streamlined. There are, however, bottlenecks in some areas and subsidiary companies which are being appropriately addressed by CILREWA.

The Chief Advisor also expressed his happiness about Life Certificate Camps being organised by CILREWA team every year and wished that such practice will be continued in future with same spirit and enthusiasm.

Regarding the demands placed by the Association for enhancement of CPRMSE benefits viz. increase in Domiciliary ceiling limit of Rs 36000/- per annum and OPD & Hospitalisation Ceiling Limit of Rs 25 Lakh, the Chief Advisor opined that at this juncture it seems to be a difficult task but CILREWA will keep on pursuing these issues with CIL Management on regular basis to get the desired result.

Chief Advisor urged upon all members to co-operate and strengthen CILREWA team for achieving the objectives.

## **6.3 Address by the Vice-President:**

Sri T. K. Sinha, Vice- President mentioned that CILREWA has been holding series of meetings with the Chairman and other functional Directors of CIL for settlement of the demands mainly for enhancement of OPD & Hospitalisation Ceiling Limit of Rs 25 Lakh and Domiciliary ceiling limit of Rs 36000/- per annum. But, this may take some time because of paucity of Trust Fund.

He also informed the house that CILREWA has taken up a programme to sensitise the spouses about the receivables from CIL i.e. CPRMSE benefits, procedures to claim Spouse Pension etc. by way of organising Awareness Camps in and around Kolkata. He felt happy that such activity of CILREWA is getting very positive response from members and their spouses. The Association has plans that the benefits of the Awareness Camps reach all members. He requested the members to come forward with suggestions and problems faced, if any, by them.

He also stated that like previous years, the Life Certificate Camps will be organised this year also in and around different locations of Kolkata. He further mentioned that this is a wonderful opportunity for the members and their spouses and requested everyone to avail the facility provided by CILREWA.

The Vice-President further stated that now the time has come to have a separate and permanent accommodation of CILREWA for better functioning of the Association and also for giving better service to the members. Apart from the funding from own limited resource, as mentioned by the Secretary, CILREWA , it is necessary to explore different ways for raising fund by way of

organising cultural programmes/Seminars, bringing out Souvenirs, obtaining donations/sponsorship, etc. This requires participation from all members.

He also requested all members to participate in the programs and events organised by CILREWA to make these a grand success and also to encourage the organisers.

## **6.4 Address by the President:**

Sri A. K. Debnath, President, CILREWA explained that there is substantial shortfall / gap between the Actuarial liability calculated as on 31.03.2025 towards CPRMSE and the actual funding to the Trust Fund. The main cause of concern of CILREWA is how to bridge the gap? Unless the solution to this is found out i.e. to finance the gap, there may be trouble in continuation of the CPRMSE Scheme in the long run. However, CILREWA team has been taking up the matter with CIL authorities rigorously for early settlement of the problem.

The demands for enhancement of OPD & Hospitalisation Ceiling Limit of Rs 25 Lakh and Domiciliary ceiling limit of Rs 36000/- per annum are being pursued but, a positive outcome is expected only after effective solution of the shortage of fund in the trust.

Regarding issuance of Revised PPOs and SOP (Standard Operating Procedure) for early settlement of spouse pension, various steps were taken. CILREWA had several formal and informal meetings with the Chairman, CIL & Dir (MP&IR), CIL to emphasize severity of the problem faced by spouses and also to impress upon CIL top brass for holding meetings with CMPFO, SBI (being nodal bank) and Subsidiary Companies and also to raise this issue in BOT Meeting for streamlining the procedure. Apart from these, several communications were also made with CMPFO directly. Pursuant to the formulation of the SOP now, settlement of spouse pension in cases where Revised PPOs have been issued, are streamlined. Revised PPOs are also being issued in phased manner.

Regarding accommodation/ Office Space, it is necessary that CILREWA has its own building and for that it requires effective planning and implementation to meet the fund requirement.

He also observed that there is very poor participation of the members in some of the events organised by CILREWA and requested for spontaneous participation of members in meetings and different programs to encourage better coordination and cooperation amongst themselves. He also emphasised formation of zonal committees to encourage diversified functioning with huge participation and also to extend helping hand to each other.

## **6.5 Question- Answer Session:**

The Question- Answer Session was conducted by Sri Umapada Bhowmik. The session mainly revolved around some questions relating to CPRMSE benefits. The doubts and queries of the members were clarified and the provisions were once again explained thoroughly.

**7.Election of office bearers of the association** Sri A K Debnath, President CILREWA declared dissolution of the Central Executive Committee (CEC) 2024-2025 and announced election for the CILREWA CEC members for the year 2025-26.

The house unanimously decided that the present committee which took over on 19.09.2024 will continue for one more year.

However, the post which had fallen vacant due to bereavement of Sri Gautam Bandyopadhyaya needed to be filled up. Accordingly, Ms Mitra Mukherjee proposed the name of Sri Udayendu Das as CEC member in the place left by Sri Gautam Bandyopadhyay. Sri P K Chakravarty seconded the proposal. The house accepted the same.
